### 4. FIRST AID MEASURES

#### First aid measures for different exposure routes

<b>General advice</b>	Avoid contact with skin, eyes, and clothing. Avoid breathing, vapors, mist, or gas.

### 5. FIRE-FIGHTING MEASURES

#### Suitable Extinguishing Media
